## MINUTES OF DISTRICT QUALITY ASSURANCE SUB-COMMITTEE FAMILY PLANNING INDEMNITY

#### Held on 19th July 2022

## Venue:- Office chamber of the District Medical & Health Officer (DMHO) Ri Bhoi District Nongpoh.

The meeting is chaired by Dr. M. Syiemlieh DM&HO Ri Bhoi District.

Members of the District Quality Assurance Sub-Committee Dr. M. Syiemlieh (DMHO), Dr. D. Blah (Addl. DMHO), Dr. B. Warbah (Gynaecologist), Dr. D. Hajong (Surgeon) are present in the meeting.

1. The DM&HO brief about the Family Planning Indemnity Scheme to the members and in formed them that the DM&HO office have received the letter from Smt. Ibanrilang Syngkli R/O Diwon Nongtluh stating the failure of Tubal Sterilization which she had undergone on the 17/7/19 at Civil Hospital Nongpoh. The client stated that she has conceived again as per her USG report dated 4/7/22 which shown a single life fetus in the Uterine cavity with 15 weeks 3 days gestational age.

2. Medical records from Nongpoh Civil Hospital are examined by the Committee and the application submitted by the client including all her documents related to her pregnancy are ALSO

examined by the committee.

3. According to Family Planning Indemnity Scheme the beneficiary should claim within 90 days from occurrence of failure sterilization. However the client came to know about her pregnancy on 4/7/2022 detected by USG and by then the client is 15 weeks 3 days pregnant. Hence the Committee decides to consider the 4/7/2022 as the first day of her claim.

4. Inview of all the findings as per records, examination, and investigation the committee deem it fit and proper to recommend the payment of Rs 30,000 (Thirty Thousands) only based on failure of Tubal ligatation.

The DM&HO conclude the meeting with a vote of thanks.
