The main agenda of the meeting is to review one case of sterilization failure filed to the Committee.

The Addl. DMHO informed that there is one case of sterilization reported and claim for Family indemnity Scheme.

It is reported by the Addl. DMHO, Ri Bhoi District, that verification of documents was done through the Sub Committee on the 19th/7/2022. According to Family planning indemnity Scheme the beneficiary should claim within 90 days from occurrence of failure. However, in this case the client came to know about her pregnancy on the 4th/7/2022 detected by USG and by then she was 15 weeks 3 days pregnant. Therefore, the Committee decides to consider, the 4th/7/2022 as the first day of her claim which is agreed by the committee.

The Committee after examining all the medical records, relevant documents related to this case found that the claim is genuine and this committee deem it fit and prefer to recommend the payment of Rs. 30,000/-(Thirty thousand) only, to the client based on failure of Tubal Ligation.

The Chairman of the Committee and the committee members agree and recommend to submit the claim to the State Quality Assurance Committee to do the needful from their end.
