Scope of Work: Supply and installation of Copier & LCD Projector and accessories.

• The bid is required to be submitted in two parts. One part in the Technical Bid and the other part is the Price Bid. The Bidder shall submit the bids in two separate envelopes. One envelope shall contain Technical Un-Priced Bid and the Price Bid in the second envelop duly marked as "Technical Un-Priced Bid" and "Price Bid" respectively. Both the envelopes shall then be sealed in one outer (main) envelope.



The main envelope must be sent to the Mission Director (NHM), Health Complex, Upper New Colony, Laitumkhrah, Shillong - 793003, Meghalaya.

 Bidder must submit authorization letter against this particular tender enquiry, failing which the quotation will be rejected without further notice.

EMD: Rs.1,50,000.00/- (Rupees One Lakh and Fifty Thousand Only) should be submitted along with the bid in the following manner:-

- Crossed demand draft drawn on any Nationalized Bank in favour of Mission Director, National Health Mission, Payable at Shillong.
- EMD submitted in any form other than as specified above shall not be accepted and shall lead rejection of the offer.
- No interest shall be paid by National Health Mission on EMD. The EMD of unsuccessful bidders shall be returned within a reasonable time or after expiry of the validity period.
- National Health Mission, Meghalaya reserves the right not to consider the offer of those bidders, whose services against any other contract have been found unsatisfactorily.
- Incomplete offers, conditional offers and offers without EMD shall be rejected.
- 6% Bank Guarantee will need to be submitted in favour of Joint Mission **Director**, **NHM** only for successful vendors/company, before issue of work order.

EMD shall forfeit in the following events:

- If the offer is withdrawn during the period of validity of the offer or any agreed extension.
- If the offer is modified/altered in a manner not accepted to National Health Mission, Meghalaya.
- If the tenderer backs-out.
- If the tenderer attempts to procure the contract by furnishing false/incorrect documents and by giving false declarations.

Technical Un-priced Bid

- The Bidder should be a firm of reputation having sufficient expertise and experience in the subject area with sound warranty/service support capacity. The firm should also have the capacity and experience supply and installation of Copier & LCD Projector and similar works.
- Bidder must have services facilities at Shillong. Details of these service support facilities must be mentioned.
- The equipment supplied should cover one year comprehensive warranty of the equipment's. However, this warranty shall be restricted against any damages cause to the equipment by the electrical fluctuations/malfunctioning and lightning at the National Health Mission, Meghalaya premises.

TENDER TERMS

- Court Fee Stamp of Rs.25/- to be attached along with the Tender.
- Tender Fee of Rs. 500/- in the form of Bank Draft from a recognized bank duly pledged in favour of the undersigned. The Tender Fee will be non-refundable.
- Photocopy of PAN/TAN Card to be enclosed.
- Professional Tax clearance certificate valid for the period 2019-20, 2020-21, 2021-

22 otherwise tender is liable to be rejected.

- IT returns for Non-Tribal or ST Certificate for Tribal (in case of proprietorship).
- Audited financial statements for last three years.
- Average Turnover of three financial years.
- GST registration along with current GST return Certificate to be enclosed otherwise tender is liable to be rejected.
- Tender should be sent in sealed envelope super-scribing the enquiry numbers and date of opening.
- Prices quoted should be on the basis of FOR Districts/delivery at site. The purchaser will not pay separately for transit insurance, all risks in transit being exclusively if the contractor and the Purchaser shall pay only for such stores as are actually received in good condition in accordance with the contract.
- The rate of compensation for delay is 0.5% per week subject to a maximum of 10% of the tendered value of work.
- Quotation should be valid for at least 120 days from the date of opening of the tender.
- The time for and the date of delivery of the stores stipulated in the Purchase Order shall deemed to be essence of the contract and delivery must be completed not later than the date specified therein. Failure to do so, without adequate justification may involve cancellation of the contract, at the discretion of the Purchaser.
- a) Prices are required to be quoted according to the units indicated in the annexed tender form. When quotations are given in terms of units other than those specified in the tender form relationship between the two sets of units must be furnished.
- b) Corrections, if any, must be attested. All amounts shall be indicated both in words as well as in figures. Where there is difference between the amounts guoted in words and figures, amount guoted in words shall prevail.
 - The purchaser reserves the right to accept or reject any quotation fully or partly and cancel the tender without assigning any reason
 - **Payment terms:**

Item Sl.No.1: Full payment within 30 days from the date of receipt and acceptance of material ordered.

- Late Tenders will not be considered.
- a) All taxes/duties/levies whether by Central/State/Local government where legally leviable and intended to be claimed should be distinctly shown separately (in percentage and words) in the tender, otherwise price quoted will be treated as inclusive of all taxes.

While quoting the tender, the tenderer should take into account all the extant statutory deductions under Central/State/Local statutes where legally leviable and show it separately (in percentage and words) and if not separately shown it will be treated as inclusive of all statutory deductions applicable as per the extant statutes.

b) Our's being a Department of Government of Meghalaya, we are exempted from

payment of Excise Duty/Customs Duty.

- The contractor shall at all times indemnify the purchaser against all claims which may be made in respect of the stores for infringement of any right protected by Patent. Registration of design or Trade Mark and shall be taken all risks of accidents or damage, which may cause a failure of the supply from whatever cause arising and the entire responsibility for the sufficiency if all means used by him for fulfillment of contract.
- **Arbitration:** In the Event of any question, dispute or differences arising under these conditions or any conditions contained in the Purchase Order or in connection with this contract (except as to any matters the decision of which is specially provided for by these conditions) the same shall be referred to the sole arbitration of the Mission Director or any other person appointed by him. It will be no objection that the arbitrator is a Government Servant that he had to deal with matter which the contract relates or that in the course of his duties as a Government Servant he has expressed views on all over any of the matters in dispute of difference. The award of the Arbitrator shall be final and binding on the parties of this contract.

It is a term of this contract: -

- If the Arbitrator be the Mission Director, NHM.
- in the event of his transferred or vacating his office by resignation or otherwise it shall be lawful for his successor-in-either to proceed with the reference himself or to appoint another person as Arbitrator or
- in the event of his being unwilling or unable to act or any reason, it shall be lawful for the Mission Director to appoint another person as Arbitrator or

b) If the Arbitrator be a person appointed by the Mission Director, NHM:-

In the event of his dying neglecting or refusing to act, or resigning or being unable to act, for any reason, it shall be lawful for the Mission director either to proceed with the any reason. It shall be lawful for the Mission Director either to proceed with the reference himself or to appoint another person as arbitrator in place of the outgoing arbitrator. Subject as aforesaid, the Arbitration Act 1940 and the rules there under and any statutory Modifications thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this Clause. The Arbitrator shall have the power to extend with the consent of the Purchase and the Contractor the time of making and publishing the ward. The venue of an arbitration shall be the place as the Purchaser in his absolute discretion may determine Work under the Contract shall if reasonably possible, continue during Arbitration Proceedings.

- Packing and Forwarding: The Contractor will be held responsible for the stores being sufficiently and properly packed for transport by rail, road, sea or air to withstand transit hazards and ensure safe arrival at the destination. The packing and marking of packages shall be done by and at the expense of the Contractor.
- "The Purchaser reserves the option to give price preference to the offers from Public Sector Units and/or Small Scale/Cottage Industries/Units over those from other firms in accordance with the policies of Government from time to time".
- Should a part or whole of systems covered by this order be delayed in delivery due to reasons of Force Majeure which shall include lock-outs, strikes, riots, civil

commotions, fire accidents, acts of God and war stoppage of deliveries by Government; refusal of non-receipt of import license for import items, the delivery period referred in their order shall be extended by a period(s) not in excess of duration of such force majeure. East party undertakes to advice the other as soon as it becomes aware of the circumstances of such force majeure, so that actions under the provisions of this order can be mutually reviewed and agreed upon between the tenderer and NHM. If the force majeure condition extends over a period of two months both the parties of the order shall mutually discuss and arrive at the agreement for continuation or termination of the contract.
